A Year of Advocacy and Progress: The Progress: The 2023 Report on HIV and AIDS Activities

The year 2023 has proven to be a pivotal and dynamic period for the HIV and AIDS community. This report delves into the extensive activities carried out by the All-Party Parliamentary Group (APPG) on HIV and AIDS, highlighting key events, initiatives, and the collective efforts undertaken to combat the epidemic.

In 2023 the APPG were responsible for:

- 219 written questions
- 5 debates
- 245 mentions of HIV in parliament.
- To mark World AIDS Day over 100+ members showed their support to tackle



The year commenced with a reception honouring Mildmay Hospital, a crucial player in specialist HIV service delivery. Vice Chair Lord Fowler addressed the audience. In attendance were parliamentarians from both Houses of Parliament.

We held a meeting with the Minsiter or State for International Development Andrew Mitchell MP, to discuss our priorities and what more the UK Government can do in the global fight against HIV and AIDS. Since then we have been working closely with him and his team on issues on global HIV.



In February we took active participation in HIV Testing Week by hosting a drop in session along with Terrence Higgins Trust so that Parliamentarians could show support and advocate to get people tested.







During testing week a thought-provoking debate organized by Vice Chair Maggie Throup MP took place where members of the APPG advocated for better access to testing along with the expansion of HIV opt out testing in A&E departments to all high prevalence HIV areas in England.

On HIV is not a Crime Day we hosted an event focused on the Criminalization of HIV and LGBTQ around the world, this was in collaboration with Amnesty and the HIV Justice Network. The event showcased the APPG's commitment to addressing complex challenges and brought those affected by the discriminatory laws to speak to parliamentarians.



In March a delegation led by Vice Chair Lord Collins attended by the Liberal Democrat spokesperson on Foreign Affairs Layla Moran MP and Charolotte Nicolls MP to Kenya, observing the commendable work of the Global Fund and UNITAID. There they met with organisations helping the LGBTQ community, Women and Girls in providing testing, prevention and care services.









On 20-23 March 2023, Co Chair David Mundell MP led a Commonwealth Parliamentary Association UK delegation to visit to the Parliament of South Africa, the fist in over a decade. The visit consisted of two days of meetings with civil society and two days in the parliament. The civil society engagements concerned the countries HIV response, LGBTQ communities along with domestic Violence.

We also marked the loss of Vice Chair Baroness Masham, a stalwart since the APPG's inception in 1987.



We also attended the poignant "Fighting HIV Stigma" march in London, uniting over 30 HIV charities. The march started at County Hall, crossed Westminster Bridge, passed the Houses of Parliament and continued up Whitehall to Trafalgar Square, as people carried banners and signs calling for an end to HIV stigma

In April, Co-Chair Baroness Barker engaged with the Nigerian High Commissioner to discuss collaborative efforts in ending new HIV transmissions. During the meeting it was discussed how the UK could support Nigeria in their HIV response that didn't involve money. One suggestion was for the UK to help build a surveillance system that would allow Nigeria track and predict patterns. We also spoke of the rights of LGBTQ people and that addressing their rights would enable Nigeria combat HIV and AIDS as a public health issue.





The launch of the Stopaids report "Access Denied". This 'Access Denied' report explored a systemic lack of transparency within government decision making between pharmaceutical companies and their relations with governments. Through legal and investigative research, the report uncovered how this opacity prevented public accountability and good governance which, we argue, contributed to the gross inequity we have seen in access to COVID-19 health technologies.

Collaborating with Positively UK, we co hosted an event where they launched their manifesto for those living with HIV in the UK. The report was and is complementary to our Quality of Life Report that we launched on World AIDS Day 2022.



May brought participation in the Silence=Death event at Conway Hall, demonstrating solidarity with Switchboard and THT. There we heard the testimony of those on the front line of the response to AIDS and HIV.

Co-Chair Steve Brine's advocacy against discriminatory policies regarding HIV-positive individuals' access to fertility treatment gained prominence in the House of Commons Chamber. Following the exchange we wrote a letter to the minister advocating the change as part of the campaign led by National AIDS Trust.

In June we attended the HIV Prevention England conference, where new data on HIV optout testing in A&E Departments was presented that showed the scheme was working. Following that conference we again wrote to the Secretary of Health and Social Care to advocate the expansion of opt out HIV testing in A&E departments to all high prevenance areas in England.

Co-Chair Florence Eshalomi MP met with Angelina, co-author of "Our Stories Told By Us," emphasized the importance of individual from the black community narrative during the past 40 years of HIV and AIDS.



In July, Vice Chair Lloyd chaired a meeting addressing the critical issue of ending HIV among children and preventing AIDS-related deaths. During the meeting it was advised that antiretroviral treatment coverage in children continues to lag behind adult treatment coverage. It was presented to the attendees of the meeting that studies are being carried out in Zimbabwe and the UK on how to help children manage their care and keep taking their medication.

In another debate Nicola Richards MP led a debate on expanding Opt-Out HIV testing in England. Again members of the APPG strongly advocated for the expansion of the scheme to all high prevalence areas of England.

The APPG's unique participation in Zero HIV Stigma Day showcased its commitment to global anti-stigma efforts. Working with IAPAC and NAZ we created videas from the co-chairs of the APPG and Lloyd Russell Moyle MP our vice chair who isconly a few elected officials openly living with HIV.



September featured an event emphasizing the importance of not forgetting the voices of the Black Community in the fight against HIV and AIDS. We had speakers representing women, queer men of colour and the migrant community on what was needed to be done in the UK to address those needs. Following the event we wrote a letter to the Secretary of State for Health and Social Care regarding the issues raised.

We also held a photo drop-in session for parliamentarians to show support for Sexual Health Services in their area.











During the 66th Commonwealth Parliamentary Conference that was hosted by the Parliament of Ghana in Accra, Co Chairs Rt Hon David Mundell MP and Steve Brine MP along with Vice Chair Peter Gibson MP spoke with parliamentarians in Ghana concerning the LGBTQ discriminatory laws that were being discussed. There they emphasised that the laws were wrong and if implemented they would hamper the countries HIV response.

During a debate led by member of the APPG Kate Osborne MP in October the government's announced changes in access to fertility treatment for people living with HIV marked a significant milestone. This followed a campaign led by National AIDS Trust.

November witnessed Co-Chair Flo speaking at the unveiling of the London Lighthouse plaque, commemorating a pioneering center for people with HIV.





Vice Chair Maggie Throup MP met with IAVI to discuss the work being carried out on vaccine development.



During a debate in the House of Lords, Co Chair Baroness Barker secured a meeting with the Defence Minister to discuss the ongoing policies that discriminate against those armed personal that are living with HIV.

During Prime Ministers Questions Co Chair Rt Hon David Mundell MP asked the Prime Minister when would HIV opt out testing would be expanded to all high prevalence areas in England and would he congratulate Sir Elton John and the Elton John AIDS Foundation on the work they have done over the past 40 years especially the work carried out that led to HIV opt out testing in England. The Prime Minister praised the work of Sir Elton and the foundation.

We also held a photo drop in session for parliamentarians to show support in tackling HIV Stigma. Over 100 members came and took a photo.









The culmination of the year was the reception honouring Sir Elton John for his relentless efforts in the global fight against HIV and AIDS. The event was attended by 150 people that included 110 parliamentarians.

The event heard from Co Chairs Rt Hon David Mundell MP and Florence Eshalomi MP, Leader of the Opposition Sir Keir Starmer MP, Speaker of the House Lindsay Hoyle MP and the Secretary of State for Health and Social Care Victoria Atkins MP.





During this event, the Secretary of State for Health and Social Care announced the expansion of HIV opt-out testing in A&E to all high prevalence areas in England. Sir Elton also had private meeting with Leader of the Opposition Sir Keir Starmer MP, Speaker of the House Lindsay Hoyle MP and the Secretary of State for Health and Social Care Victoria Atkins MP and the Minister of State responsible for International Development Andrew Mitchell MP.

In January we held a round table with ViiV Healthcare and Sophia Forum where we discussed HIVand women.

The meeting assessed the barriers causing gender inequalities in the uptake of HIV testing, prevention and treatment and proposed policy solutions to address these barriers.

Key takeaways were:

- HIV testing uptake is highest among eligible gay, bisexual and men who have sex with men (74%) and lowest among eligible women (38%).
- Just 36% of women identified with a pre-exposure prophylaxis (PrEP) need initiated or continued PrEP in 2022. Amongst men who have sex with men, the proportion was 74%.
- · While HIV diagnosis is declining in white gay and bisexual men, cases in heterosexual women rose by 26% from 447 in 2021 to 564 in 2022.
- There were 94,397 people living with diagnosed HIV infection and accessing care in England in 2022, of which a third (32%) were women.



We were pleased to host an event in Parliament focussed on inequalities and quality of life, with 80 people in attendance. It was in conjunction with HIV Outcomes UK, a project led by National AIDS Trust. This included a presentation on the recent Positive Voices 2022 report from the UK Health Security Agency and University College London. This is the largest UK survey of people living with HIV, offering important insights into the way HIV impacts communities and it is a key resource to inform Government policy-making.

Encouragingly, the report highlights that people living with HIV continue to have a high level of satisfaction with their HIV care service and treatment. However, inequalities mean that this is not an even picture. For example, more than half of people living with HIV do not routinely have enough money to easily cover their basic needs. 2 in 5 of people living with HIV have also been diagnosed with at least one mental health condition, substantially higher than the general population. This adds further evidence to something we have long-known: that underserved communities, including trans people, face barriers in realising their right to health.

The history of the HIV response shows what is possible. Working in partnership with communities, parliamentarians have played a key role in securing the transformational progress to date. But to ensure we do not lose the opportunity of being the first nation to end new HIV transmissions, the Government must accelerate work to end inequalities. Through this, we can make sure that everyone living with HIV not merely survives, but thrives.

For HIV testing testing week, we organised a drop in session for parliamentarians to show support and encourage people to get tested.

42 parliamentarians attended. It's recommended you test for HIV at least once a year and more regularly if you've had unprotected sex or more than one partner.

We also had a debate in the chamber of the House Of Commons on HIV Testing week where Charlotte Nichols MP lead with contributions from Andrew Slaughter MP, Jim Shannon MP, Sir Peter Bottomley MP, Preet Gill MP and Andrea Leadsome MP took part.













Co Chair Rt Hon David Mundell met with Professor Matt Philips the president of BASHH.

They discussed, access to PrEP, the current situation with Sexual Health Services, Workforce and how the APPG and BASHH can work closely together.

we held a reception for HIV is not a crime day with HIV Justice Network. With Edwin Barnard CEO of the HIV Justice Network and Lisa Power.

While there has been some progress towards reforming HIV criminal laws globally, research by the HIV Justice Network has revealed that HIV criminalisation remains a significant issue in the Commonwealth. If we are to end the HIV epidemic, HIV criminal laws must be repealed.

However, as of February 2024, 20 jurisdictions in 17 Commonwealth countries still have HIV-specific laws in place. This includes one Commonwealth country, Nigeria, in which there are multiple jurisdictions with HIV-specific laws.

In total, there have been reports of HIV criminalisation in 43 jurisdictions in 25 Commonwealth countries. These include cases in all eight Australian states, eight provinces and territories in Canada, two Nigerian states, and all four nations of the United Kingdom.

In recent years, we are aware of HIV cases in 21 jurisdictions in 12 Commonwealth countries. These are the jurisdictions in which HIV criminal cases have been reported in the past five years, highlighting that HIV laws continue to be actively enforced in the Commonwealth.





We hosted an event co-organised by the APPG on Malaria and NTDS and STOPAIDS on Saving Lives Faster: Ending preventable deaths of women by 2030.

The aim of the meeting was to to hear from multilaterals, research institutions and communities about some of the innovative treatments and support approaches that are playing a role in saving women's lives globally and how these need to be strengthened.



Co Chairs Rt Hon David Mundell, Florence Eshalomi and Baroness Barker met with Matthew Lindley, Resource Mobilisation Manager, Unitaid and Janet Ginnard Head of Strategy, Unitaid.

They spoke of the work UNITAID are doing and the partnerships they have with Global Fund.





'To mark British Science week, we co hosted an event with STOPAIDS on British health R&D: Innovation that delivers global impact to reach the SDGs by 2030'.

There we heard how Unitaid collaborates closely with The Global Fund to Fight AIDS, TB and Malaria, enhancing the impact of investments into global health in resource constrained environments. Unitaid plays a crucial role in identifying and creating innovative health products, swiftly bringing them to market for those who need them most. The Global Fund, as a major provider of key health commodities, supports over 120 countries in deploying these innovations at scale and at affordable prices. Both institutions play complementary yet distinct roles in ensuring access to health products and providing essential care at an affordable price to those most in need. Health and economic gains from every dollar invested in the three diseases are 16% higher with health innovations piloted by Unitaid and scaled up by the Global Fund.



Looking Ahead to 2024

As the APPG reflects on the successes of 2023, plans for 2024 take shape. The focus will be on advocating for better education and access to PrEP in the UK and a more global focus on prevention in general, replenishing the Global Fund and the Robert Carr Foundation, securing increased and stable funding for sexual health services in the UK, advocating the reform of anti-HIV and LGBTQ laws globally, observing "HIV is not a Crime Day," promoting HIV testing week, and enhancing research into women and HIV.

We also will be writing two reports in 2024. One Domestic on the state of the UK HIV and Sexual Health Services and one Globally focussed on criminality.

The APPG also stands firm on demanding compensation for those affected by the contaminated blood scandal. We will also be emphasizing better access to HIV testing, prevention, and care services for the Black Community.

The year 2023 has been a year of relentless advocacy, collaborative efforts, and significant milestones in the fight against HIV and AIDS. The All-Party Parliamentary Group on HIV and AIDS has played a pivotal role in shaping the narrative, addressing challenges, and working towards a world where HIV is no longer a threat. As 2024 approaches, the APPG remains steadfast in its commitment to creating a future free from the burden of HIV and AIDS.
